4a (Code: ) (Expenses \$ 808,856 including grants of \$ ) (Revenue \$ ) Moriah House - Family Shelter - Moriah House provides immediate, temporary solutions to those who find themselves homeless due to domestic violence, poverty and other circumstances beyond their control. In a safe and welcoming environment, families begin to address the issues surrounding the circumstances that led to their homelessness and are assisted with finding more permanent housing solutions. In 2018, 11,234 nights of lodging and 33,552 meals were provided to 92 families along with transitional services and referrals to provide more long-term solutions.

4b (Code: ) (Expenses \$ 691,402 including grants of \$ ) (Revenue \$ ) Resource Center - Day Shelter - The Resource Center addresses the immediate needs of the marginalized and homeless population in the Cleveland area by providing services such as meals, clothing, showers, mailboxes and first-line medical attention for health issues resulting from exposure. In 2018, 35,098 meals and 3,359 instances of street survival and outreach & advocacy services were provided to individuals and families in need. Outreach & advocacy services are highly personalized and address the core issues that underlie a person's poverty in order to encourage them to become more independent. Over 7,000 clients were served by the Resource Center in 2018.

4c (Code: ) (Expenses \$ 1,035,609 including grants of \$ ) (Revenue \$ ) Zacchaeus Housing Solutions - Long-Term Rapid Rehousing - Zacchaeus Housing Solutions helps families secure and maintain housing by providing rent subsidy and case management services for up to twelve months. Zacchaeus Housing Solutions' ultimate goals are to end family homelessness and to strengthen family unity through housing stability, increased life skills, and job placement. In 2018, 111 families consisting of 125 adults and 292 children were successfully placed in permanent housing.
